The research area I worked on at CREA is Social Farming; in particular, I worked on two projects: the first one concerns the economic efficiency of Italian penal agricultural colonies, which are prisons with a semi-farming a semi-commercial organisation in which inmates perform agricultural tasks. For this project, I analysed the initial economic and business situation of the penal colonies and, following a technical-economic feasibility analysis, I drew up proposals regarding the most profitable activities to be carried out and the most efficient business model to be adopted. This information was collected in several technical reports transmitted to the Italian Ministry of Justice. I was also responsible for the creation of a database on Access with all the economic, physical, technical, and social information related to the project, which will support the tracking of results and the management. With regard to the ‘Custodi di comunità’ project, which aims at the socio-occupational inclusion of NEETs and people with psycho-physical disabilities, I have been in charge of the evaluation of the project results with the methodology of the SROI (Social Return On Investment).
