She graduated in Law from the “La Sapienza” University of Rome, supervisor Prof. O. Diliberto.

In 2011 she was first classified in the competition for the 27th cycle of the *PhD* in Roman Law at the University of Rome "La Sapienza", a title she obtained on 26 March 2015, with an "*excellent*" rating, discussing a dissertation entitled: “*Le leges regiae: the testimonies of Dionysius of Halicarnassus*”.

In the academic year 2011/2012, she attended the "Higher Education in Roman Law" course at the University of Rome "La Sapienza".

Since January 2013, she has been an expert on the subject and a member of the examination commission for the teaching of History of Roman Law (and, since January 2014, also of that of Institutions of Roman Law) held by Prof. D. Di Ottavio, at the " University of Tuscia" of Viterbo.

From November 2014 to December 2014 she followed an intensive German language course at the “Goethe Institut” in Munich, Germany.

Since December 2014 she has been part of the Editorial Committee of the Bulletin of the "Vittorio Scialoja" Institute of Roman Law.
