Ongoing

Full professor of Comparative Public Law (SSD IUS/21) at Unitelma Sapienza University of Rome since 2016.

At the same University, since 2009, he has held the courses of Environmental and Sustainability Law, Environmental Law and Procedure of Territorial Autonomies, Comparative Environmental Governance, Methodology of Legal Sciences, Comparative Public Law, Cultural Heritage Law, Comparative Law of Groups and Minorities, Lobbying Law, and Comparative Law of Public Security.

He is Director of the UNESCO Chair on Intangible Cultural Heritage and Comparative Law. He has been appointed by the Rector as « Student Guarantor ». He is member of the Academic Senate.

He is, also, Director of the School of Cultures, Politics and Democracies at the Department of Law and Digital Society.

Since 2010, he has been professor of Lobbying Theory and Techniques, master's degree program in Political Science, at Luiss Guido Carli, Rome.

At the same university, he is also lecturer in Comparative Law of Pressure Groups and Regulating Heritage Markets at the Master's degree program in Policies and Governance in Europe.

Since 2018, he has been a member of the Scientific Steering and Coordinating Committee of the Scientific Studies Series of the National Anti-Corruption Authority (ANAC).

He is a member of the Rome Bar Association (list of university professors).

2010-2016

From 2014 to 2016, he was associate professor of Comparative Public Law at Unitelma Sapienza University of Rome.

At the same university, he was, from 2010 to 2014, permanent researcher in Comparative Public Law (IUS/21).

From the academic year 2011/2012 to the academic year 2017/2018, he was adjunct professor of Cultural Heritage Legislation and Institutional Relations at the Master in Management of Art and Cultural Resources at IULM University in Milan.

2006-2010

From July 1, 2008 to June 30, 2010, he was fixed-term researcher in Institutions of Public Law at the Faculty of Economics, University of Siena.

During the academic years 2006/2007, 2007/2008, 2008/2009 and 2009/2010, at the Faculty of Economics, University of Siena, he was Adjunct Professor of Regional Law.

In the 2006/2007 academic year, he was an adjunct professor of Constitutional Law - Module II at the Faculty of Law, LUMSA University of Rome.
