Brief Description

<p>2014 “English Globally: State of the Art and changing scenarios”, 2017 “English Lingua Franca: Expanding scenarios and growing dilemmas”, 2021 “ELF Emergence: migratory flows, transient international groups and educational settings”.</p>
<p>1- ELF – the principal area of research is represented by the sociolinguistic aspects involved in the description, use and spread of the English language nowadays. Assuming the ELF (English Lingua Franca) function and perspective as vantage point within the sociolinguistic approach to the teaching and learning of the English language - set in a genuinely communicative framework of reference - the research activity focused on the negotiating practices put into action in contexts of multilingual and intercultural communication in academic settings, informal conversational exchanges via digital resources and social networks, and more formal circumscribed circumstances such as MUN (Model United Nation).</p> <p>The dedication to this specialized area of research (ELF) gave life, among other initiatives and publications, to three international symposia (see above): in 2014 “English Globally: State of the Art and changing scenarios”; in 2017 “English Lingua Franca: Expanding scenarios and growing dilemmas”; in 2021 “ELF Emergence: migratory flows, transient international groups and educational settings”, where internationally authoritative experts gathered and debated the most updated questions. They were all held at Sapienza University (the latest one, in 2021, in hybrid form). The audience was represented by scholars, professors, researchers, school teachers and students. This aspect ensured dissemination of the new gains and findings. In total, approximately 900 participants attended the three symposia (the 2021 symposium was both in presence and on zoom, streaming).</p>
<p>2- The other main field of research is represented by Translation and Translation Studies. Here the interest is concentrated on the theoretical acquisitions of the discipline, in an updated view; on the other hand, practice is ensured through the actual translation workshop activity, working on a variety of texts in terms of language and domains, adopting TAP (Think Aloud Protocol) techniques, with a preference for poetical/experimental texts, and advertisements, as specialized discourses. This has also created a special focus on TILT (Translation in Language Teaching, G. Cook, 2010), Translation and Education (S. Laviosa, 2014) and Corpus linguistics / Parallel corpora.</p>
<p>3- Finally, the gains and findings of the two above mentioned areas were set and used as projective development (in terms of linguistic improvement and cultural growth) of the future applied linguists and educators, in a teacher training perspective, also in view of a genuinely “third mission” or “teacher education” perspective.</p>
